(b) Other Significant Interests (OSI) under the Kent Code of Conduct as adopted by the Council on 19 July 2012, relating to items on this agenda. The <u>nature</u> as well as the existence of any such interest must be declared, and the agenda item(s) to which it relates must be stated.

A Member who declares an OSI in relation to any item will need to leave the meeting <u>before the debate and vote</u> on that item (unless a relevant Dispensation has been granted). However, prior to leaving, the Member may address the Committee in the same way that a member of the public may do so.

- (c) <u>Voluntary Announcements of Other Interests</u> not required to be disclosed under (a) and (b), i.e. announcements made for transparency reasons alone, such as:
  - Membership of outside bodies that have made representations on agenda items, or
  - Where a Member knows a person involved, but does <u>not</u> have a close association with that person, or
  - Where an item would affect the well-being of a Member, relative, close associate, employer, etc. but <u>not</u> his/her financial position.

## **Resolved:**

# **160** Review of Single Grants Gateway Funding Priorities

The report explained that a review of the Single Grants Gateway funding and eligibility criteria was being considered by Cabinet later that evening, and subject to Cabinet's approval of the recommendations made in the report, the Terms of Reference of the Single Grants Gateway Panel would need amending. A revised Terms of Reference reflecting the recommended changes was attached to the report.

In response to a question from a Member about 'pre-notification' the Funding & Partnerships Officer explained that 'Expressions of Interest' still applied. The

Member said that the application should state clearly if the local Parish Council had been approached for funding.

A Member asked about the external representative from the Kent Invicta Chamber of Commerce, who had not been attending Panel Meetings. The Chairman said that the intention was to invite the Chairman of the Ashford Branch of the Kent Association of Local Councils (KALC) to replace the Chamber of Commerce in that role. The Terms of Reference would also have to be amended accordingly.

## **Recommended:**

That subject to the approval of the Cabinet to the recommendations made in the report regarding the review of the Single Grants Gateway funding and eligibility criteria, the revised Terms of Reference of the Single Grants Gateway Panel be approved, subject to a further amendment replacing the External Representative from the Kent Invicta Chamber of Commerce, with the Chairman of the Ashford Branch of the Kent Association of Local Councils (KALC).

#### TERMS OF REFERENCE OF THE ENVIRONMENT & NATURE CONSERVATION FORUM

At the inaugural meeting of the Environment & Nature Conservation Forum on the 24<sup>th</sup> October 2013 a Mission Statement and Terms of Reference were presented for agreement. They were a combination of the two previous Fora (Nature Conservation Forum and Environmental Forum).

During discussion the Open Space and Landscape Officer requested that Point 9 of the Terms of Reference be amended to include open space sites in the Borough, this was agreed by the Forum.

An amended version of the Mission Statement and Terms of Reference has been appended to this report.

That the Selection and Constitutional Review Committee agrees the Mission Statement and Terms of Reference, as amended, and that this be added to the Council's Constitution.

## MISSION STATEMENT AND TERMS OF REFERENCE

#### **Mission Statement**

- The Environment and Nature Conservation Forum will research, examine, review, collate, report, inform, advise and recommend to the Portfolio Holder & Head of Culture and the Environment, on aspects of the environment relevant to the Borough of Ashford which include, but are not limited to:
  - Nature conservation, ecology and biodiversity
  - Landscape management and design
  - Use, access and connectivity of open space
  - Waste reduction, recycling and renewable energy
- 2. The Environment and Nature Conservation Forum will provide an opportunity for organisations with an interest in the sustainable development <sup>1</sup> of Ashford to work together to address the protection and improvement of the local environment and to contribute to the resolution of local, national and global problems.
- 3. The Environment and Nature Conservation Forum will work in partnership to provide a framework to initiate and advance environmental programmes across Ashford. In particular to promote and monitor the sustainability process in the Borough and to stimulate awareness on environmental issues.

## Terms of Reference:

1. To consider actively and influence policies to safeguard the environment insofar as it may affect the ability of Ashford Borough Council to create and service a high quality growing sustainable community.

- 2. To report to the Portfolio Holder and the Head of Culture and the Environment, who in turn will exercise their discretion in reporting, informing and recommending to Cabinet.
- 3. To ensure an integrated and seamless interface with other local, regional and national organisations whose activities involve stewardship of the environment and to be aware of the shared opportunities with neighbouring councils and landowners.
- 4. To consider what actions can be taken to further improve waste management and increase recycling within the Borough.
- 5. To promote and influence the further development of safe cycling and walking routes within the Borough and beyond, and the provision of secure cycle storage areas in key locations.
- 6. To review and/or examine how to support and develop corporate priorities, including town centre improvements.
- 7. To specifically examine best practice and innovation by others and to review, examine and promote ways in which we can reduce the use of finite resources in favour of sustainable and renewable energy.
- 8. To work with appropriate agencies, partners and other groups to promote the protection, enjoyment, enhancement and maintenance of our countryside and its biodiversity together with the Borough's heritage and rich historical architecture.
- 9. To consider matters arising from the management of nature conservation sites and open space site within the Borough.
- 10. To work together with organisations such as the Kent Wildlife Trust, Kentish Stour Countryside Partnership, The Conservation Volunteers and other local and community based groups to identify other potential nature conservation sites in the Borough and to support efforts at developing partnerships and projects to enhance nature conservation and biodiversity within the borough.
- 11. To work in partnership with relevant local and regional organisations and agencies in support of the development of new open space sites.
- 12. To consider how sustainable drainage and flood defence arrangements can be effectively integrated into the environment.
- 13. To consider the possible impacts of climate change on the Borough and to contribute towards the development of (i) appropriate *mitigation* policies and actions to address the root causes, and (ii) *adaptation* policies and actions to lower the risks posed by the consequences of climate change.

#### **CONSTITUTIONAL ISSUES**

Further to the Meeting of this Committee held on the 7<sup>th</sup> May 2013, there is a need to update on some minor issues arising from the report 'Background and Principles of Political Balance and Administrative Structure'.

With regard to the Parish Forum, the Leader has signified his wish that the seats originally allocated to himself and Councillor Claughton on behalf of the Conservative Group should be re-allocated to Councillors Mrs Bell and a Councillor TBC. Councillor Mrs Bell is also proposed to be appointed Chairman of the Parish Forum with the Councillor TBC as Vice-Chairman. The ex-officio position previously referred to should therefore be removed.

This will necessitate some minor amendments to the Terms of Reference of the Parish Forum (page 87 of the Constitution refers) as shown at Appendix 1 to this report.

In addition, with regard to Committee Membership, it should be noted that the Labour Group's seat on the Education & Vocational Skills Advisory Committee has been passed to Councillor Britcher (this was previously held by Councillor Chilton).

- (i) Councillors Mrs Bell and a Councillor TBC take the Conservative Group's seats on the Parish Forum.
- (ii) Councillor Mrs Bell be appointed Chairman of the Parish Forum with a Councillor TBC as Vice-Chairman.
- (iii) The Terms of Reference of the Parish Forum be amended accordingly as outlined at Appendix 1 to the report.
- (iv) Councillor Britcher take the Labour Group's seat on the Education & Vocational Skills Advisory Committee.
