REPORT OF THE MONITORING OFFICER

SUMMARY OF ALLEGATIONS OF MISCONDUCT MADE TO STANDARDS BOARD FOR ENGLAND

- 1. It has been agreed that it would be helpful for members to be made aware of allegations of misconduct made against Borough Councillors and Parish Councillors within the Borough which the Standards Board for England have either (a) investigated and determined or (b) chosen not to investigate. In relation to the latter, the information is given in the table below is in the form of a statistical summary only as it would be inappropriate to give personal details. In relation to the former, summaries of decisions are published on the Standards Board website and where these are available I have attached a copy of the published summary.
- 2. In addition to the cases set out below, I am aware of four outstanding Parish or Town Council cases within the Borough which are the subject of ongoing investigations and these will be reported when a decision has been made.

summary

It was alleged that Councillor John Lindsay failed to treat the clerk of Appledore Parish Council with respect at council meetings between January and September 2002, and that this led to the clerk's resignation. Councillor Lindsay allegedly questioned the clerk's advice that he should not take photos of local properties in his capacity as a member of the Planning Committee.

The Ethical Standards Officer considered that Councillor Lindsay was entitled to question the clerk's advice. The Ethical Standards Officer also considered that the advice from external bodies did not categorically state that Councillor Lindsay should not take photos. The Ethical Standards Officer concluded that Councillor Lindsay did not fail to treat the clerk with respect.

The Ethical Standards Officer found that there was no evidence of any failure to comply with the Code of Conduct.

The allegation in this case relates to Paragraph 2(b) of the Code of Conduct. Paragraph 2(b) states that a member must "treat others with respect".

summary

It was alleged that Councillor James Took failed to treat the clerk of Appledore Parish Council with respect at council meetings between January and September 2002. Councillor Took allegedly questioned the clerk's advice and sought to become a liaison officer with the Kent Association of Parish Councils (KAPC), a role normally performed by the clerk. This behaviour allegedly led to the clerk's resignation.

The Ethical Standards Officer considered that Councillor Took was entitled to question the clerk's advice. The Ethical Standards Officer also considered that Councillor Took was allowed to liaise with the KAPC in the specific circumstances (circumstances of which the clerk was unaware at the time). The Ethical Standards Officer concluded that Councillor Took did not fail to treat the clerk with respect.

The Ethical Standards Officer found that there was no evidence of any failure to comply with the Code of Conduct.
