### 513 MATTER REFERRED FOR LOCAL INVESTIGATION - CASE LGA/KM/104 (SBE 10761.05)

The Chairman welcomed everyone to the meeting.

The Monitoring Officer explained the procedure: the matter had been referred by the Standards Board for England for investigation. The investigation had been undertaken by an external investigator. The Investigator had found no breach of the relevant Code of Conduct.

The Committee now had to decide:-

- (i) Whether it accepted the Investigator's findings that there had been no failure to comply with the relevant Code of Conduct or whether the matter should be considered at a Hearing of the Standards Committee.
- (ii) Whether it accepted the recommendations set out in paragraph 7.3 and 7.7 of the report.

The Monitoring Officer and Committee discussed the report. The report was felt to have been well investigated and the Committee agreed with the Investigator that there appeared to have been no breach of the Code for any of the four allegations. However, the Committee expressed concern over the conduct referred to in paragraphs 6.4 and 6.5 and felt this had not been appropriate. The Committee asked the Monitoring Officer to draw the attention of the Parish Council to these concerns.

The Committee considered the recommendations brought forward within the report. They felt it was important for Parish Councils to follow the appropriate Good Practice protocol. They also confirmed that where possible meetings should be held in public venues.
