Policy Overview:	The budget is a matter for the Full Council to approve. As part of the statutory requirement and status of the budget, the proposals for 2023/24 work towards delivering the Council's priorities in the Corporate Plan.
Financial Implications:	The budget supports the Corporate Plan and is the result of considerable input from Members and services over several months. It is below the level set within the medium term financial plan which forecast £5, the maximum permitted without referendum at the time of setting the MTFP. The recommended budget requirement (excluding parish precepts) is £18,642,710. The recommended Council Tax at Band D is £181.25, an increase of £3.75 from 2022/23.

Report Title: Budget and Council Tax Resolution 2023/24

Important notice

1. The resolution in this report, which must include the requirements of all precepting authorities, are based on the Precepts agreed by the precepting authorities.

Proposal/Current Position

2. To present the Cabinet Committee's 2023/24 General Fund Budget and Council Tax recommendation for resolution by the Full Council. It presents the full statutory resolutions, including the requirements of the Precepting Authorities (as known at the time of writing) and the Parish Councils, for the areas covered by the Borough Council as the Billing Authority.

Issues to be decided

3. The Full Council is required to consider and approve the recommended 2023/24 Budget and the Council Tax requirement. The Full Council must also agree the statutory resolutions, which include the Precepting Authorities' requirements.

Ashford Borough Council's General Fund Budget and Council Tax Requirement and Consultation

- 4. The decisions of the Cabinet, at its meeting on 23 February 2023, are included in the relevant minute on this agenda, with the budget summary included at **Appendix C**.
- 5. The report to the Cabinet Meeting included advice required by the Local Government Act 2003, on the robustness of the estimates and the adequacy of the Council's reserves.
- 6. It should be noted that the period for budget consultation closed on 10 February 2023. The Council received five replies, which were tabled, with responses at Cabinet on the 23 February 2023.

Council Tax Requirement

7. The demand on the Council Tax Collection Fund for 2023/24 that flows from the recommendation of the Cabinet, and the decisions of the Precepting Bodies totals £102,677,395, analysed as follows: -

Council Tax Resolution

The Council is recommended to resolve as follows:

- 1. It be noted that on **27 October 2022** the Cabinet calculated:
 - a. The Council Tax Base for 2023/24 for the whole Council area as 48,906 (Item T in the formula in Section 31B(3) of the Local Government Act 1992, as amended (the "Act")) and,
 - b. For dwellings in those parts of its area to which a Parish precept relates as in the attached **Annex A**.
- Calculation that the Council Tax requirement for the Council's own purposes for 2023/24 (excluding Parish precepts) is £8,864,210 (Appendices A and B).
- 3. That the following amounts be calculated for the year 2023/24 in accordance with Sections 31 to 36 of the Act:

- 106,847,705 being the aggregate of the amounts which the Council estimates for the items set out in Section 31A(2) of the Act taking into account all precepts issued to it by Parish Councils.
 - 95,364,350 being the aggregate of the amounts which the Council estimates for the items set out in Section 31A(3) of the Act.
 - 11,483,355 being the amount by which the aggregate at 3(a) above exceeds the aggregate at 3(b) above, calculated by the Council in accordance with Section 31A(4) of the Act as its Council Tax requirement for the year. (Item R in the formula in Section 31A(4) of the Act).
 - 234.80 being the amount at 3(c) above (Item R), all divided by Item T (2 above), calculated by the Council, in accordance with Section 31B(1) of the Act, as the basic amount of its Council Tax for the year (including Parish precepts).(Annex C)
 - 2,619,145 being the aggregate amount of all special items (Parish precepts) referred to in Section 34(1) of the Act (as per the attached Annex B).
