

### Codfather - Conditions

### To promote all four licensing objectives

The Licence Holder shall liaise closely with the Police in connection with the operation of the licence and in order to promote the four licensing objectives.

The Licence Holder shall take such steps as are necessary to promote the four licensing objectives i.e. the prevention of crime & disorder, public safety, the prevention of public nuisance and the protection of children from harm.

### The prevention of crime and disorder

A CCTV system shall be designed, installed and maintained in proper working order. Such system shall be:



Thank you for your email.

I question your assessment of unfairness. The notice displayed at the premises was the one which you were informed was not valid, and not the corrected version which we advised was suitable. Additionally a notice in this week's paper is past the statutory period. You have invalidated your own application — Whilst we have clearly assisted you to try and ensure you have a valid application, and I would highlight that it is not for the licensing authority to continually 'hand hold' applicants who repeatedly appear to be unable to complete the process properly.

Despite the errors with the application, I do not consider it appropriate to require a new application (and payment) to start again. Instead I would suggest that the 28 day period is restarted (if done within the next few days) with new notices being displayed and also placed in the newspaper with a new end date.

Please could you advise me what day you will be able to install the new and valid notices, and what date a new notice will be displayed in the paper? I can then provide the end date for representations based upon the start date for you to complete that part of the notice. 
