Further written comments from Shadoxhurst Utilities and Drainage Team were received on 08 June 2022. The comments are summarised below:

- Consider PTP foul water drainage option should be discarded;
- Consider corrected Nutrient Neutrality Assessment that addresses current Natural England guidance should be submitted.

In response to the first comment the applicant has confirmed that the proposals do not rely on an on-site PTP foul water drainage system. As set out in paragraph 84 of the Officer report off-site mitigation measures will be required in order for this development proposal to achieve 'nutrient neutral' status.

In response to the second comment, given the uncertainty regarding timeframes and the potential for Natural England to issue further guidance prior to the determination of the planning application it is not necessary to require updated calculations until such a time as the Appropriate Assessment can be progressed.

No amendments to the Recommendation are necessary.
